Description:

The story of the other Mozart, Maria-Anna, a child prodigy forgotten to time, as seen through the eyes of musicians, musicologists, and researchers.

Like her younger brother, Maria-Anna Mozart was a keyboard genius from an early age and the siblings toured Europe performing as wunderkinder to royalty. As a child it was acceptable for Maria-Anna to play in public. But when she reached 15, societal norms compelled her to retire. Tantalising clues exist of her continued virtuoso playing as well as her interest in composing music. Using recreations and expert interviews, Madeleine Hetherton-Miau (producer, China Love SFF 2018) explores the fascinating theory that Maria-Anna Mozart played a larger role in her brother's music than is previously known. Like Charmian Clift – Life Burns High (screening at the Festival), Mozart's Sister turns our gaze towards the unrecognised female creators of our time.







Minderoo is an Aboriginal name meaning place of permanent and clean water. The majestic Ashburton River is a life-giving artery that provides shady respite for both humans and beasts. It winds its way through the deep inland of the Hamersley Ranges, which were named after Margaret Forrest (nee Hamersley), the wife of Minderoo Station co-founder John Forrest. The river travels through immense grasslands, scattered with acacia bush and rivergums, through red sand hills and hummocks of spinifex to the coastal plains.

The story of Minderoo Station is one of fortitude, endurance and great vision. It is one of pioneers pushing into new frontiers, and of both hardship and triumph in conquering the unforgiving north of Western Australia. But, above all, it is a tale of family, love and the strong ties that have bound the Forrest family as generations have worked to realise the potential of the Ashburton region for almost 150 years.



Summit Framing and Overview

Summit Framing and Overview:

The Minderoo AI Summit brings together 32 leading global experts to identify and explore ways to improve stakeholder alignment and action towards safe and responsible AI.

The programme is designed to support leading scholars and policy makers in sharing their expertise and experiences around AI system impacts, power dynamics and innovative opportunities for policy coordination. The frame for our discussion is sociotechnical, grounded in both human experience and human rights.

As the pace of AI development and use continues to accelerate, timely and effective governance by regulators, developers and deployers of AI is increasingly critical to prevent harm and ensure that the benefits of AI are broadly shared. This summit addresses the urgency of states and organisations adopting robust and effective frameworks to understand and manage both the positive and negative impacts of AI systems.

Summit sessions and interactions will provide participants with ample opportunities to present their expertise and experiences, fostering both collaboration and actionable insights. We hope the ideas generated during discussion will be help guide future philanthropic investment in innovative and responsible Al initiatives.



Session 1: Impact Friday, 2pm

The first session will focus on the topic of 'impacts', and explore questions including:

- How do we prioritize and address the most significant AI-related harms when there is disagreement among experts about their relative importance?
- How can we practically ensure that stakeholder voices and contexts including those
 of marginalized and vulnerable communities –are included in both achieving the benefits
 of AI systems and mitigating AI harms?

Session 2: Power Saturday, 8:30am

The second session will focus on the theme of 'power', addressing questions such as:

- How are political, social and economic power dynamics shaping the outcomes and impacts of AI?
- What sources, drivers and concentrations of power are over-stated or under-estimated in relation to regulating the safe and responsible development, deployment and use of AI systems?

Session 3: Participant ideas and initiatives Saturday, 2pm

The third session will be structured as an 'Unconference', an open space for participants to propose and lead discussions on topics or initiatives of their choice.

An unconference session allows attendees to drive the agenda, promoting spontaneous, dynamic, and participant-driven conversations.

From the morning of the second day, participants will have the opportunity to suggest and vote on themes or topics for the third session. It is common for this to result in several smaller, tightly-focused discussion groups running in parallel.

To make the best use of this final session, participants are encouraged to reflect on initiatives, ideas, research questions and collaborations that they believe would benefit from input, energy and investment from their peers and other supporters.



Context

In August 2024, Dr Andrew Forrest, co-founder of the Minderoo Foundation, invited thought leaders to Minderoo Station for an open and candid conversation on Artificial Intelligence. The sessions, held under the Chatham House Rule, sought to explore and identify ways to improve stakeholder alignment and action towards safe and responsible AI.

The Summit was facilitated by \$ 22

. Over two days, participants were guided through discussions and small-group sprints, aligned to the focal areas of: *Impact, Power*, and *Participant Ideas and Initiatives*.

Given the open and candid nature of the discussions, it would be impractical to capture all the sentiments and points of view that were canvassed. As such, this high-level summary aims to record points of impact and / or recurring themes which can provide an on-going reference point for the Minderoo Foundation's action in the field.

Framing

Prior to the first session, \$ 22 offered four points to assist in housing the conversation:

- 1. Consider how are we aligning, igniting and building ideas
- 2. Identify the ends and the means
- 3. Focus on mitigating the harms
- 4. Base our discussion in evidence not polemic

Session One

On Friday afternoon we discussed the **Impact(s)** of AI. Conversation generally agreed that the harmful impacts of AI are real and exist on multiple levels.

As an existential threat, Al is generating system-level shifts that undermine human values, trust and culture; threatening our systems of government and global stability. It has stifled open research, encouraged the monopolization of markets, underscored the outsourcing of humanity and weakened individual agency.

More immediately, the rapid adoption of AI - at scale – has led to the global community experiencing the *impacts* of a pervasive and largely unregulated technology. It has supported the routine breaching of internationally agreed human rights, as well as consumer, competition, privacy, negligence, intellectual property and corporate laws. A recurring point was the impacts of the malicious use of AI to corrupt the free exchange of information and undermine truth.

It was observed that the very nature of AI, notably its statistical algorithmic programs, can make it hard to predict or replicate results. This often complicates control mechanisms and is often seen as a barrier to effect control measures.

Session Two

Leveraging the previous discussions on Impacts, on Saturday morning participants reconvened to explore the concept of **Power** as it relates to AI. It began by defining power as: 'the ability of an actor to express their will without constraint'. Participants broadly agreed that a power imbalance exists, in favour of a very small group of technology companies, who wield disproportionate influence and / or control.

Small-group sprint sessions unpacked ideas on the sources of power from point of impact to upstream entities. Of interest, groups held a prevailing view that obfuscation of accountability protocols, economic markets and regulating authorities had accelerated the identified power imbalance. That a false notion of *openness*, *free markets* and *a spirit of unconstrained development for the benefit of humanity* prevailed. In mapping and attempting to address this power dynamic, a theme emerged that humans appeared to be unaccountable for AI.

Following the sprint, participants consolidated their thoughts in a group circle. Here, ideas were respectfully contested and a sharper understanding of the power dynamics and their sources evolved. It was observed that *data*, the enabler of AI algorithms, was a foundational source of power.

It was equally observed that, despite their willingness, recognised authorities, including governments, regulatory bodies and international organisations, had experienced a – real or perceived - reduction in their power *to* act on AI. A related point saw discussion around the need for new regulation for AI and approaches that can keep pace with technological advances. Comments here revived thinking on democracy and social contracts - galvanising thought on the role of an informed and empowered citizenry.

Resulting discussion touched on the need for AI development to be more transparent and accountable. The concept of "red lines" for developers was introduced, that could be paired with independent assessments and audits, and / or improved regulations or more effective application of existing laws. It was understood that the regulation of AI is a global, large-scale and multi-faceted issue. There are significant challenges in coordinating responses internationally. This includes the implementation of standards, while also navigating diverse national interests.

The session concluded with commentary around the critical role of civil society, public campaigning, strategic litigation and local community involvement have in shaping AI policies and addressing AI harms. It noted that expanding "grassroots" approaches could mean impacted citizens are active participants, have a voice, share their experiences and can be involved in the design of solutions.



16-18 August 2024

Session Three

The third session provided an opportunity for attendees to test ideas and initiatives against an emerging framework of action. The framework comprised three complimentary bodies of work, exploring the role of people, effective legislation and establishing red lines around impermissible actions.

1. The People's Al Watch / Observatory: Educating and empowering citizens to demand transparency, safety, and a share in the power of Al products.

The group explored innovative methods for supporting widespread stakeholder engagement on Al policy issues at scale, leveraging the latest approaches to real-time, data-driven citizen conversations. This would surface information on actual harms, citizen priorities, and opportunities for worker and community benefits from Al. It would help guide policy makers and regulators in prioritising action, and – as Taiwan's experience has shown – increase public trust in government. This aspect comprises "ensuring regulatory action and corporate investment in Al serves the lived experience of humans".

2. Enabling Regulators: enhancing the enforceability of existing regulatory frameworks and structures that are currently outgunned and under-resourced.

The group explored the urgent need to provide support to regulators to expand and make use of their capabilities in relation to AI. This would help regulators devise and deliver coordinated enforcement action against organisations whose behaviour is representative of common and severe risks and harms affecting people and society. It would also greatly enhance regulator capabilities to guide the market, support civil society organisations in representing harms, and support individuals seeking redress via regulators. This aspect comprises "upgrading the engine" for safe and responsible AI, for example, by supporting action around directors' duties by corporate regulators in key jurisdictions.

3. Establishing universal, targeted, technical and provable "red lines" for AI systems to ensure that they are safe and beneficial prior to being available on the market.

The group discussed new rules that would put the burden of proof on AI developers to verify with high confidence that AI systems will not exhibit a specific set of harmful behaviours that could massively scale AI harms. Potential examples of "red lines" include red lines on AI systems choosing to self-replicate, providing advice on weapons of mass destruction, or breaking into other computer systems. This aspect comprises "adding critical security features" for safe and responsible AI.

Complementing these, the group recognised several other important efforts worth integrating into the above, including:

- Supporting strategic, civil litigation that directly addresses egregious harms, creating public awareness, helpful precedents and complementing regulatory action.
- Supporting the creation of repeatable, scientifically valid assessment and audit approaches for testing and understanding the impacts of AI systems.

And finally, on the Sunday morning, in response to Andrew's request, we discussed a "north star" during closing remarks which the group seemed to think *could* be phrased as:

"Shifting The Power From Machines To Humanity"

Next steps / Conclusion

Minderoo Foundation was fortunate to gather such a talented group of people for the Al Summit. We see value in this being a base for further activity and opportunities to work together. Many attendees commented on the unique opportunity to convene as a group. It was remarked that this was the first time many participants had engaged one-to-one and across disciplines. Minderoo Foundation sees the Summit and the many relationships formed as an opportunity to inform its future efforts in the field.
