Dear all,

We are writing with some regulatory updates from eSafety about Phase 1 Codes and Standards, Phase 2 Codes, and the Basic Online Safety Expectations (**BOSE**).

Phase 1 Codes and Standards (Class 1 Material)

Industry Standards Regulatory Guidance

Phase 1 Industry Standards will regulate Relevant Electronic Services (**RES**) and Designated Internet Services (**DIS**) in relation to Class 1 material. The Standards are due to commence on 22 December 2024. eSafety has now published regulatory guidance to assist industry in implementing the Standards.

The existing regulatory guidance for Phase 1 Industry Codes has also been updated. This includes updates noting that:

- eSafety will not take enforcement action against services which are currently required to comply with the Social Media Services Code for not providing an annual compliance report, where they are now required to comply with the RES standard from 22 December 2024.
- eSafety will not take enforcement action against services who do not participate in an annual forum in year one of the codes' application (that is, 16 December 2023 – 15 December 2024), as required by the Social Media Services, Equipment Services, and App Distribution Services Codes. This follows a request from the industry associations in Australia.

Following Parliamentary scrutiny, eSafety has also published supplementary explanatory statements to the RES and DIS Standards, to provide further clarity on protections in relation to end-to-end encryption, and the treatment of Class 1B material, amongst other matters. The supplementary explanatory statements can be found on eSafety's register of industry codes and standards: [Register of industry codes and industry standards for online safety | eSafety Commissioner](#), as well as the Federal Register of Legislation.

Annual code compliance reports – suggested templates

Mandatory annual code compliance reports covering the first year of Phase 1 Industry Codes operation are required to be provided to eSafety by **15 February 2024**, by the following service providers:

- Tier 1 social media service providers (that are not required to comply with the RES Standard)
- Tier 1 equipment services/operating system providers

eSafety has published suggested code compliance report templates and guidance to assist these service providers prepare and complete their annual code compliance reports. While these templates are optional, they provide information and guidance on what eSafety considers are helpful to include in a code compliance report. We encourage industry associations responsible for developing the Social Media Services Code and the Equipment

Services Code to share the suggested code compliance report templates and guidance with their members.

Industry Codes and Standards Compliance Portal

Service providers regulated by Phase 1 Industry Codes can now access eSafety's Industry Codes and Standards Compliance Portal to communicate with and provide eSafety the following information and reports as required by the applicable industry code:

- Changes to the functionality of their service or a new feature
- App removals notifications
- Code compliance reports.

Service providers can also submit general enquiries through the portal. All other information or notifications required to be provided to eSafety should continue to be sent to codes@esafety.gov.au. We encourage industry associations to share the portal link with their members.

Phase 2 Industry Codes (Class 1C and Class 2 Material)

eSafety received interim draft Phase 2 codes from industry associations on 3 October 2024, as required by the notices for code development issued in July. eSafety thanks everyone who contributed to the production of the draft codes. As required under the *Online Safety Act*, public consultation on the draft codes has now commenced and will be open until 22 November 2024. We look forward to receiving final draft Phase 2 codes for assessment by 19 December 2024. After this time eSafety will consider whether the codes contain appropriate community safeguards and should be registered, or if there is a need to develop any industry standards. 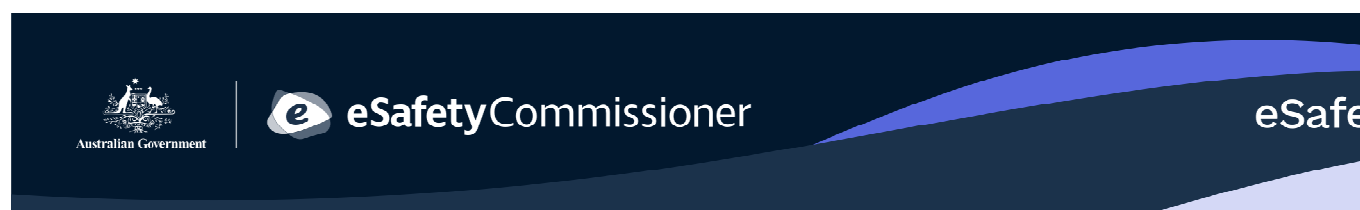

Hi ClothOff,

Thank you for your response.

As set out in our correspondence of 14 November 2024, eSafety has now published Regulatory Guidance to assist industry in implementing the Standards, which can be found at the eSafety website: [Regulatory guidance | eSafety Commissioner](#). We note that the [Designated Internet Services \(DIS\) Standard](#) referred to below is now in force.

We encourage you to read the Regulatory Guidance in full, and particularly pages 45 to 48 which contains an explanation of the scope of the 'high impact generative AI DIS' category and its respective obligations. The guidance also notes that to ensure service providers have sufficient time to prepare, eSafety will not take enforcement action in the first six months of the Phase 1 Standards coming into effect, apart from exceptional circumstances such as in response to serious or deliberate non-compliance.

Thank you for advising us that ClothOff has made changes. Could you provide us with details of what those changes consist of? We are also happy to discuss any questions you may have regarding compliance.

Dear all,

As you are aware the *Online Safety (Relevant Electronic Services— Class 1A and Class 1B Material) Industry Standard 2024* and the *Online Safety (Designated Internet Services— Class 1A and Class 1B Material) Industry Standard 2024* (the **Standards**) were registered on 21 June 2024 and commenced on 22 December 2024. Five industry codes in relation to Class 1A and Class 1B material have also been in force since 16 December 2023, with another commencing on 12 March 2024 (the **Codes**).

eSafety stated in its [regulatory guidance](#) it would not take enforcement action until six months after commencement of the Standards, other than in exceptional circumstances. This 6-month period was intended to give services additional time to improve their compliance with the Standards. That period has now ended.

eSafety's compliance and enforcement priorities for applicable Industry Codes and Standards for the next six months are:

- i. key 'proactive' obligations, in particular the detection, disruption and deterrence of child sexual abuse material and pro-terror material;
- ii. ensuring user reporting mechanisms are compliant; in particular that they are clear, harm-specific, and reports are actioned appropriately and in a timely manner;
- iii. obligations in relation to generative AI;
- iv. safety by design/safety feature obligations, such as privacy by default settings for children's accounts; and,
- v. ensuring services have sufficient trust and safety resources, and that these possess appropriate skills, experience and qualifications to comply with applicable codes and standards.

While these will guide our prioritisation of matters for enforcement, eSafety may take action in relation to any failure to comply with the industry Codes or the Standards, in particular where there is a risk to the online safety of Australians.

eSafety will continue to proactively monitor compliance, including through use of our investigation and information gathering powers, where appropriate. This may also involve testing of services to ensure certain required features or processes are present and compliant, and/or to ascertain the risks on a service.

In general, and subject to any submissions by providers, eSafety will publish details of enforcement action taken, in the interests of transparency and to ensure specific and general deterrence.

For the avoidance of doubt, receipt of this correspondence does not necessarily communicate any specific compliance concern, but is for the information of a wide range of services.
