About eSafety

The [eSafety Commissioner](#) (eSafety) is the Australian Government's independent online safety regulator. Our job is to help people have safer, more positive experiences online. We do that by:

- helping people remove serious online harm like cyberbullying and image-based abuse
- working with tech companies to make their platforms safer
- creating education programs, tools and campaigns that build people's confidence online.

We know young people are the experts in their own online experiences, that's why we created the Youth Council to help make sure your voices guide what we do and how we do it.

How we support you

Our team works behind the scenes to support the Youth Council and amplify your voices. To turn your ideas into impact, we:

- make sure that every meeting is **engaging and inclusive**
- **provide resources and training** so that members feel confident sharing their ideas
- **turn your insights into action** by feeding them into eSafety's programs, campaigns and resources
- **celebrate diversity** and make sure every voice is heard.



What are you signing up for?

Being on the Youth Council means using your voice and experiences to help shape how eSafety supports young people online. As a member, you'll:



Meet regularly online (and two in-person meetings) with other members from around Australia



Share what life online is really like for young people



Give feedback on eSafety's projects, from resources and campaigns to policies and research



Represent the Youth Council at events and workshops



Build your confidence and skills in communications, teamwork and leadership

Time, commitment and reward

We know life's busy, so your involvement can flex around school, uni or work.

You'll meet young people from across Australia and learn from different perspectives.



What do we discuss in the meetings?

The Council talks about all kinds of issues that affect young people online, like:

- cyberbullying and harassment
- mental health and wellbeing
- impacts of algorithms and recommender systems
- unwanted online contact
- sexual extortion and coercive control
- impacts of generative AI and deepfakes.

You will also have the opportunity to suggest online safety topics that you feel are relevant to young people and important to address.

What else could you do on the eSafety Youth Council?

There are plenty of ways to get involved beyond the regular meetings. Past members have:

- **met with senior leaders** of Big Tech organisations
- **presented and spoken at various national and international events** to share youth insights, including the Digital Childhoods Summit in Canberra and the DG CNECT Safer Internet Forum
- written and launched an [open letter to Big Tech companies](#) on Safer Internet Day 2023
- written a submission and presented further evidence to the [Joint Select Committee on Social Media and Australian Society](#)
- consulted with eSafety and the Australian Government on the **social media minimum age legislation**
- **collaborated with WeProtect Global Alliance** to develop the youth-led #MyVoice #MyFuture media campaign tackling online safety, digital rights and online harm
- **co-developed 'The Digital Landscape'** with eSafety, a quarterly online safety resource designed to provide young people with bite-sized emerging online safety information and advice.
- engaged with young people from international online safety organisations as part of the Global Online Safety Regulators Network **'Youth Dialogues'**.

Before you apply

Before you send in your application, make sure you'll be available for most of the meetings and training sessions below. We know life gets busy, but the more often you can join us, the more you'll get out of the experience.

These meetings allow us to come together to dive deeper into online safety topics and meet with relevant eSafety teams. How to apply

You'll apply through a short online form via Microsoft Forms. You can answer however feels most comfortable to you – write it out, record a video, make an audio clip or upload something creative. There's no 'right' way to do it. We just want to hear your ideas and your perspective.

Ways to respond

- For text-based responses – Type your answers (up to 200 words per question)
- For video responses – Upload a video as unlisted to Vimeo, or if you're over 16 you can upload an unlisted YouTube video (max 3 minutes).
- For other creative responses – Email your file as an attachment (max file upload 25 MB) to youth@esafety.gov.au using our template in the application form.

eSafety reserves the right to refuse to review any links to or uploads of content that appear unsafe or malicious.

What you'll be asked

You will be asked:	Why are we asking this?
Your first and last name, and your pronouns	So we know who you are and how to address you
Your contact details, including your email address and phone number	To contact you. We often contact you via email but if we need to reach you quickly, we may text you.
Your date of birth	<p>To make sure you meet the age ranges of the eSafety Youth Council.</p> <p>If you are selected to join, we also keep track of our Council members' birthdays so we can wish you a happy birthday. We'll also monitor if we need you to complete a certain task, like apply for a Working with Children check in your state/territory.</p>
Your postcode	So, we can get a sense of the geographical regions of the young people applying.
Demographic questions <ul style="list-style-type: none">• Gender• If you identify as Aboriginal and/or Torres Strait Islander• If you identify as LGBTQI+• If you are from a culturally and/or linguistically diverse (CALD) background• If you identify as living with disability• If you identify as neurodivergent	These questions are optional, but they will help us know more about you and will help us form a diverse and inclusive Youth Council.

Your accessibility needs	<p>This question is optional, but if you are selected to join, this information will help us understand if there are additional supports or considerations that will help you to fully participate.</p>
Your comfort levels in: <ul style="list-style-type: none"> • Leading or facilitating meetings • Recording video or audio content • Public speaking and presenting • Writing and editing 	<p>This question is optional, but your response will help us understand how comfortable you might be with some of our regular activities.</p> <p><i>Note: There are no right or wrong answers. Your responses will not advantage or disadvantage you from being selected to join the eSafety Youth Council.</i></p>
If you have or are willing to apply for a Working with Children Check in your state/territory.	<p>Depending on the Working with Children Check requirements of your state/territory, you may be required to have a valid Working with Children Check as you will be working with young people under the age of 18.</p> <p>eSafety will reimburse you for any costs related to applying and/or registering for a Working with Children Check in your state/territory.</p> <p><i>Note: You will not be able to participate in the eSafety Youth Council without a valid Working with Children Check if you are eligible.</i></p>
Support from your parent/carer to apply (If you are under the age of 18)	<p>To let us know that you have spoken to your parent/carer about this opportunity and they are supportive of you applying.</p> <p>If you are selected to join, your parent/carer will need to sign a consent form before you are able to participate.</p>
If you had one chance to pitch an online safety issue affecting young people to the eSafety Commissioner, what would it be and what should eSafety do to help address it?	<p>To give us an idea of what online safety topic you think is important and relevant to young people, and how you think eSafety should address the issue and support young people.</p>
Why would you be a great fit for the eSafety Youth Council?	<p>To help us understand what experiences, skills, personal qualities, interests or knowledge that you have that will be a strong addition.</p> <p><i>Note: You do not need any formal or specific experience to apply. We are looking for any young person with a keen interest in online safety with natural personal qualities or learned skills and knowledge.</i></p>
